CAAT Posts 11.1% Return for 2020

The Colleges of Applied Arts and Technology Pension Plan is reporting an 11.1 per cent return for 2020, exceeding its policy benchmark by 0.4 per cent.

The return brings the annualized 10-year net return to 9.9 per cent, providing \$1.7 billion in cumulative added value compared to the benchmark, while funding reserves increased to \$3.3 billion from \$2.9 billion. This represents 11 consecutive years that the plan has improved its funded position, according to a press release, which noted the plan is 119-per cent funded on a going-concern basis based as at Jan. 1, 2021, an improvement from 118 per cent last year.

Plan assets are at \$15.8 billion, up from \$13.5 billion a year earlier.

“Despite the challenges of 2020, [the] CAAT remains one of the most secure plans in Canada,” said Derek Dobson, chief executive officer of the CAAT, in a press release. “We began the year with healthy funding reserves and I’m proud to say we ended the year stronger.”

In March, the CAAT reported its discount note was lowered to 4.95 per cent from 5.15 per cent, to reflect expected future trends in market returns and the plan’s long-term focus on benefit security. And in 2020, the plan grew by 7,500 members and by 35 employers, mainly through its DBplus offering, the CAAT said. Among the employers that have joined DBplus are Brinks Canada Ltd, the Canadian Bar Insurance Association/Lawyers Financial, Sanofi Pasteur, the Shareholder Association for Research and Education, Saint John Airport, St. John Ambulance, Torstar Corp., the United Way of Greater Toronto, The University of Saskatchewan, and the Vancouver Foundation.

Some Comments About Lifetime Memberships:

Only in 2021, during the transition period of implementing the Lifetime Membership option, do we offer a reduction of the annual fees already paid for 2021 and 2022. For example if a member had already paid the annual \$10 for 2021 and now desires to have a Lifetime Membership (and they are age 70 or older) they would only have to pay \$40 (\$50 less the \$10 already paid).

All Lifetime Membership fees are credited to an account called Deferred Revenue. At the end of the calendar year, 12% of the balance in that account will be brought into income.

One member asked what would happen to the balance in the Deferred Revenue account should the GCRC ever wind down since Lifetime Memberships are not refundable. In that situation (which we trust is unlikely) the balance would be donated to the Student Scholarship Fund.

I deal with it.

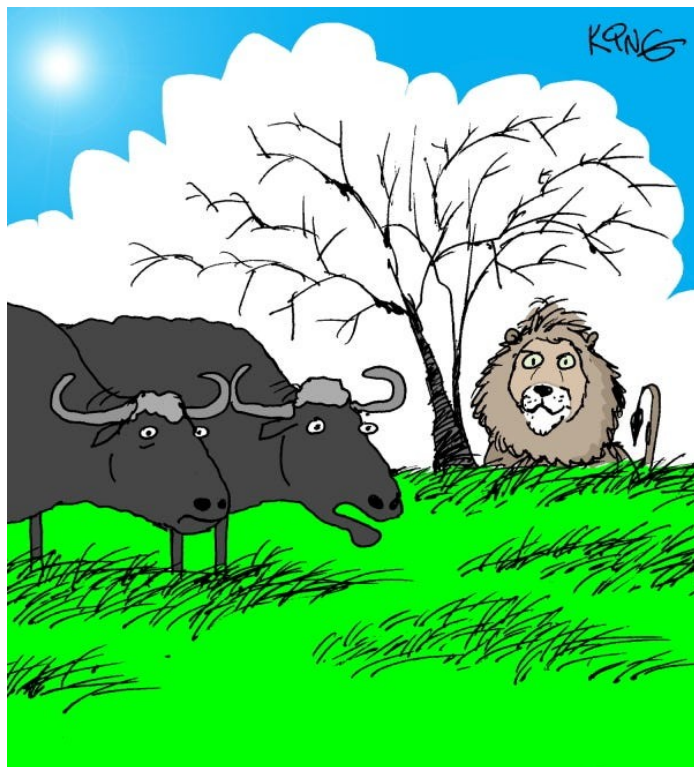
Welcome note to new retirees from 2018, 2019, and 2020

JULIE'S SCALLOPED TOMATOES

3 tbsp butter/marg	Dash Cayenne pepper
¼ C minced onion	1 ½ lbs (4 approx) tomatoes
2 C fresh bread crumbs	¼ C fresh bread crumbs
½ tsp sugar	¼ C grated parmesan
1 garlic clove minced	1 tbsp melted butter/marg
¼ tsp pepper	1 tsp Italian seasoning

Heat oven to 375°F. In small saucepan, saute onion in 3 tbsp butter til tender. Add 2 Cups breadcrumbs, sugar, salt, pepper, cayenne. Slice tomatoes thinly, and arrange layer of tomatoes in greased 1 ½ Quart casserole. Top with layer of onion bread mix. Continue layers til all is used, ending with tomatoes on top. Combine the ¼ Cup breadcrumbs with 1 tbsp butter and Parmesan cheese, sprinkle over tomatoes. Bake, uncovered for about 45 minutes.
